(3) LOWW_APP must ensure vertical separation to any traffic flying underneath LESMO area, especially, if QNH in LOWW and QNH in LHCC FIR differ greatly.

Free-Route-Airspace Agreement

Without individual coordination, enroute flights my be cleared direct to the first waypoint in the flightplan beyond the FRA entry points, as long as:

- Traffic permits
- Clearance is issued at least 5 minutes prior to crossing the respective LoR
- The original entry sector remains unchanged (i.e., the direct route does not cross another FIR)

Exceptions are:

- Arrivals to EDDM, LO**, and LH** which shall enter via the filed entry points.
- Departures from LOWG and LOWW which shall be cleared direct the exit point only.

Coordination regarding procedures and situations not listed herein shall be done in due time with the respective responsible ATC unit.
